On 3-10-2000, I received a call from ADA Jerry Rushing, requesting a photographic study of injuries related to one Janet Kimberly Williams - Kim. Injuries included trauma to vagina and injuries to lateral aspect of right thigh. I believed that part of the injury to be a human bite mark. I was supplied, by your office, four sets of dental models for comparison.

OPINION

The dental models of Emmit Ervin, James Ervin Jr., and Tami Vance, are inconsistent with the bite mark found on Janet Kimberly Williams.

The dental models of one Vikki Leigh Stubbs are consistent with the bite mark found on Janet Kimberly Williams thigh.

The injuries to Kim's vagina, appear to be masticatory (chewing) to the left labium majus and avulsion of the right labium majus, due to biting. Hematoma of the glans of clitoris is consistent with severe negative pressure. (sucking). All of which is consistent with severe oral sex.
